Jagga Reddy Slams BJP for Distorting History, Urges Youth to Recognize Nation's True Legacy

Hyderabad, May 30 (TSIT): Telangana Pradesh Congress Committee (TPCC) working president Jagga Reddy launched a scathing attack on the Bharatiya Janata Party (BJP) on Thursday, accusing its leaders of distorting historical facts and ignoring the legacy of India's freedom struggle.

spokesman Hari Prasad specifically criticized recent remarks by BJP leaders that allegedly misrepresented India's historical narrative. "Motilal Nehru, Jawaharlal Nehru, and Indira Gandhi were all born before Independence and were active participants in the freedom movement," said Hari Prasad.



leaders of its own. So they conveniently claimed Sardar Vallabhbhai Patel, who was actually a Congress stalwart," he said. In a tongue-in-cheek comment,

he added, "To understand Congress history, BJP leaders would need a time machine like the one in Aditya 369." On the sensitive issue of Kashmir, Jagga Reddy dismissed BJP leaders' comments as superficial. "At the time of the Kashmir accession, most of their fathers weren't even married," he remarked.

Highlighting the Congress party's long-standing legacy, Jagga Reddy noted that while the BJP is just 45 years old, the Congress has a political history spanning 145 years. "Congress is a political elder compared to the BJP," he said. Responding to BJP criticism of Chief Minister Revanth Reddy's recent comments, Jagga Reddy defended the CM's use of the term "our man" as a colloquial, friendly expression.

First centre fuselage for LCA Tejas Mk 1A manufactured by Hyderabad-based firm, handed over to HAL

Hyderabad, May 30 (UNI) In a significant boost to India's indigenous defence manufacturing capabilities, the first centre fuselage assembly for the Light Combat Aircraft (LCA) Tejas Mk1A was handed over to Hindustan Aeronautics Limited (HAL) by M/s VEM Technologies, the Hyderabad-based Defence manufacturing company, on Friday.

The handover took place in the presence of Secretary (Defence Production) Sanjeev Kumar and HAL Chairman & Managing Director (CMD) Dr. D. K. Sunil. This event marks the first time a major sub-assembly for the LCA Tejas being manufactured by a private

Indian company. Speaking on the occasion, Sanjeev Kumar while hailing the partnership between HAL and VEM Technologies in accelerating the production of LCA Mk 1A, said that there is a significant growth in defence production at a rate of about 10 percent annually as well as in our defence exports. This would not have been possible without the support of industries and Public Sector Units like HAL.

Security and sovereignty of the country are paramount and cannot be achieved without its own manufacturing and supply of spare parts, which could meet the requirements of the Armed Forces, he added.
